On the morning of September 1, 2019, Nevada Volunteer Fire Department was dispatched to a structure fire at 5984 Collin County Road 488 Nevada, TX 75173. It was noted by Collin County Dispatch that there was an elderly bed-ridden resident inside the home.

Upon arrival it was observed that there was smoke coming from inside the home. Chief Greg Cortez entered the home with Collin County Deputy Brandon Polk, Farmersville PD Officer Jay Crowley, and Lavon PD Officer Carissa Vargas. These four courageous individuals made entry, prepared the patient for removal from the hospital bed, and then proceeded to carry the elderly resident to a safe location. The patient was later transported to the hospital for smoke inhalation and was doing well. Mayor Kinnard presented the four courageous individuals with a crystal lifesaving commendation, plaque.

The NVFD presented a Plaque to Mayor Kinnard, Council, and City of Nevada in recognition, for Supporting the Fire department.
