# NEVADA VOLUNTEER FIRE DEPARTMENT 2022



### **MISSION STATEMENT**

The mission of the Nevada Volunteer Fire Department is to provide protection of life, property, and the environment from the effects of fires, medical emergencies, and hazards. We engage the community in our mission through progressive community outreach. We will maintain a constant state of readiness to respond to all requests for services through training, maintenance of equipment, and a desire to serve our community.



### Message from the Chief

The mission of Nevada Fire Department is to provide protection of life, property, and the environment from the effects of fires, medical emergencies, and hazards. We engage the community in our mission through progressive community outreach. We will maintain a constant state of readiness to respond to all requests for services through training, maintenance of equipment, and a desire to serve our community.

I took over the position of Chief in January 2022. Since then Nevada Fire Department has made great strides and sees no end in sight. Just a few of the things that Nevada Fire Department has accomplished includes: Becoming an ALS capable department, significantly increased our annual training, becoming voluntarily regulated by Texas Commission on Fire Protection (TCFP), implemented a set of Standard Operating Policies and Guidelines that meet "best practice" standards, transitioned from a member run department to a structured traditional department, added to our membership, updated our old command vehicle as well as added a new command vehicle.

Everyday I have to consider our changing fire district, population and needs of our citizens. As we grow, it is our responsibility to continue to provide the best service possible for our citizens and those passing through. This is being accomplished through rigorous training (Nevada had a cumulative 1167 hours of department training in 2022), never-ending learning, and a commitment to the craft. It is my philosophy and that of my command staff, that just because we are volunteers, does not mean we are not professional.

Nevada Fire Department has seen roughly a 30% increase in call volume year after year the past three years. The call volume is attributed to a greater number of people residing in our fire district as well as a greater number of people passing through. We will continue to see these numbers rise, as the city of Nevada is anticipating at least two new subdivisions starting in 2023, and The City of Josephine is slated to add an estimated 15,000 rooftops in the next couple years, and The City of Lavon to add an estimated 7,000 rooftops in the next few years. That is close to 60,000 additional people. It is inevitable that our call volume will continue to increase.

It is my privilege to present to you our 2022 annual report. This report is not what I have done for the citizens, but what my department and staff members have done. As always, I can not do what I do without my team.

## 2022-2023 COMMAND STAFF

**DEPUTY CHIEF KIDD** —Deputy Chief Kidd has been with Nevada Fire Department for a total of 14 years. He started as a probationary firefighter and rose through the ranks holding the position of firefighter, Captain and presently Deputy Chief. Chief Kidd specializes in IT, contract language, and helps by running the majority of our daytime calls for service. Deputy Chief Kidd is instrumental in assisting with the administrative side of the fire department. Deputy Chief Kidd has logged over 100 hours of training in the year 2022 alone as well as responded to 398 out of our 667 calls this year.

**CAPTAIN DAVENPORT** - Captain Davenport has been with Nevada Fire Department for close to three years. Captain Davenport was a transplant to us from the former Branch Volunteer Fire Department. Captain Davenport has been an instant role model to our firefighters. Since coming to Nevada Captain Davenport has earned his associates degree in fire science, and is always eager to learn more . Captain Davenport recently moved out of district all the way to Athens (2 hours away). Captain Davenport has transitioned into more of an administrative Captain since he lives so far away, but is regularly at the station on average once a week.

**CAPTAIN WALTERS** –Captain Walters has been with Nevada Fire Department for close to two years now. Captain Walters is also a transplant from Branch Volunteer Fire Department. Captain Walters is a full time firefighter / paramedic for Van Alstyne. Captain Walters has certifications in Rope Rescue, Vehicle extrication rescue, certified driver/ operator, as well as a host of others.

CAPTAIN JONES—Captain Jones has been with Nevada Fire about two years total. Captain Jones is a self-employed business owner by trade. Captain Jones spent 7 years with East Texas Medical (Based out of Wylie Fire Station) as an EMT. During his tenure with ETMC, he has amassed thousands of patient contacts, and gained a lot of experience. Captain Jones is tasked with being Nevada's quartermaster and EMS coordinator. Captain Jones is also instrumental in our daytime calls for service as he responded to 220 out of our 667 calls.

**CAPTAIN WILSON**- Captain Wilson has been with Nevada Fire Department almost 1 year. Captain Wilson came to us from Maryland (we don't hold that against him). Captain Wilson served as an EMS Lieutenant with his fire department up north. Captain Wilson has many certifications through pro-board including Firefighter, vehicle extrication, public fire educator as a host of others. Captain Wilson is never happy being stagnant and is always asking for more training and going and getting classes on his own as well.

### 2023 PROJECTED OUTLOOK AND GOALS

2023 Will hopefully bring some big things to Nevada Fire Department. If any of you have seen our station this past year or so, it should come as no surprise that we have been out of room for a while. Nevada Fire Department in its current state is "land locked" and we struggle to even find ample parking for our members. Nevada continues to host community event such as the community CPR class that we did, as well as host outside agency training. The other aspect of our current station is the lack of actual facilities.

One of our biggest goals for 2023 is to start the process of acquiring land for a new station build. Nevada will be looking to acquire hopefully 2-4 acres of land in the Northern end of our fire district (CR 489, CR 543, HWY 78, OR N. FM 1138 areas. 2 Acres would allow the build of a station with ample parking while 4 acres would allow us to consider future growth as well as having a dedicated training ground. (We currently use Collin College in McKinney, Community High School Parking lot, or new neighborhoods that are being developed.

A few other things we are planning on starting is the design of a new apparatus. Our current engine is a 2009 year model and it is time we start the process of spec'ing out and ordering a new engine or truck (These are approximately two year processes).

We will also be looking at some ways to compensate our guys for their time. We tried to do this in 2022, but the resounding voice from our members was they "wanted to keep the money in the department, and get better tools and equipment".

Nevada Fire Department will be adding 8-10 new hand-held thermal imaging cameras (one for each air pack) to utilize on fire scenes. These will be purchased from the proceeds of our picture fundraiser.

Nevada will be utilizing close to 14,000 of grant reimbursed funds for training courses for our members. These courses range from basic fire certifications, rope rescue, surface water rescue, high angle rescue, hazmat ops, etc.

### **INTERETED IN JOINING???**

Nevada Fire Department is always looking for and evaluating potential members to join our team. Are you the right fit? What does it take to be a Nevada Fire Fighter? What is it like to be a Nevada Fire Fighter?

What Is the hiring process? (Even though we are a volunteer department, we still utilize a hiring process, this allows those who want to go career, the experience of "the process", and hopefully prepare them for their full-time agency.

Step Three: Sit for an oral board
Step Four: Pass a background check
Step Five: Pass a drug screen
Step Six: Agility Test (Being developed, and will be implemented 1st qtr. Of 2023)
Step Seven: Sit for a Chiefs interview
Step Eight: Formal offer of position

#### CLOSING MESSAGE

So as we close out 2022, I sit back and reflect on what we have accomplished, where we may have fallen short, and contemplate some of eh most common questions we are asked. One thing about firefighters is they hate two things, the first one being "the way thing are", the second is change. I feel pretty confident in saying the group we has a whole is not effected by these issues. Our firefighters and command staff has welcomed the changes and challenges that have been implemented with fairly open arms.

It still amazes me that we have citizens and people that still are surprised that wee are still a 100% volunteer fire department. I tell my guys to carry the pride of being a volunteer on the inside and we should not feel the need to tout that in public. My expectation for Nevada is to represent ourselves as professionals. I have heard the saying "It's the Nevada way!" I take that as a compliment and look forward to progressing that mentality. I want my guys to experience the pride and acknowledgment from outsiders on their professionalism and knowledge.

I am asked quite a bit, "when is Nevada going paid?", the short answer is we are no where close to being able to afford to have paid firefighters. We are looking at going into 2023 at a deficit just based on projected expenses. As a rough idea, a single paid firefighter to include pay, insurance, retirement, etc. is around \$72,000.00 annually (this is based off of a 55,000 salary plus medical insurance, workers compensation insurance, and retirement)

Nevada is committed to continued improvement and growth, and I look forward to what this new year brings for our department. I am a huge believer in this is not about me, it is about us, that includes our firefighters, our citizens and those simply passing through our area.

Nevada has a comprehensive training plan for 2023 which includes specific officer development training, engineer (driver / operator), and firefighter training. Our training plan includes company level training as well as multi-company training (Multiple departments). In 2023, I would like to see 1500 cumulative training hours.

With the projected growth coming into the area I am projecting we will see around 873 calls for service for the year 2023. This is based on a 30% increase over what we saw in 2022. Nevada has averaged a 30% increase in call volume the past 3 years running. I want to assure you Nevada is up to the challenge and ready to move forward with the new year.

We look forward to the progression of our area, as well as services we are capable of providing.

Deuce,

If the city of Nevada decides to grant a senior citizen and/or disabled persons exemption, you can do so with, or without freezing the taxes. From your email below it sounds like a <u>senior citizen (65 or older) exemption with a freeze</u>, so my example below is on that scenario.

- The council would need to adopt a Resolution setting the amount of the senior citizen homestead exemption. I
  will use \$20,000 for my estimate below.
  - a. The council would need to include in the Resolution that that want to establish a tax limitation (freeze ceiling) on senior homestead exemptions.
- 2. For example, let's say you adopt this for 2023, would need to be done and CCAD receive the official Resolution before July 1, 2023
  - a. 2023 calculation would be the Appraised Value \$20,000 exemption, times your 2023 tax rate per \$100, to arrive at the city of Nevada 2023 Tax.
    - i. Your tax levy would be impacted by the count of homes receiving the exemption, times \$20,000, times your 2023 tax rate per \$100
    - \$20,000 exemption x tax rate of \$0.230982 per \$100= \$46.20 tax savings per home, times 130 = \$6,005 loss of levy to the city.
  - b. The actual freeze impact would begin being felt in 2024, because 2023 is the base year that uses the actual tax calculation above.
    - i. 2024 and forward the owner's taxes would continue to be set at the 2023 base year level, regardless of future tax rate increases and value increase by CCAD.
    - ii. It is impossible to know the actual impact in 2024 forward because we don't know what the future appraised value will be, nor the future tax rate.
    - iii. That said, you can do some level of prediction of future impact using the following formula to account for value growth, tax rate increases and more owners qualifying for the exemption in the future.

Sorry for the long calculation, but you can see the impact of the freeze in future years, because you have the base loss due to the exemption itself, then the loss in revenue because the taxes are frozen at the base year, therefore value increases, and tax rate increase don't increase the taxes on the frozen accounts in the future.

You can change the variables in these formulas to see the impact. Amount of exemption. Amount you expect future tax rates to be. Amount of value increase. Average value of homes that expect to get the exemption.

To illustrate the impact of the freeze, I will use Lavon, since they grant a freeze on senior citizens. Lavon grants a \$20,000 senior citizen & disabled, with freeze. They had a 0.43 tax rate for 2022. In 2022 they had 229 properties frozen.

- > Their tax levy on these frozen accounts because of the exemption with freeze was \$195,252
- Their tax levy on these accounts if they had the exemption but had not been frozen would have been \$274,450
