8. Public Hearing- Notice of public hearing for proposed budget 2023-2024 for the City of Nevada. The meeting will be held at 7:00pm, August 22, 2023, at Nevada City Hall, 424 E FM 6, Nevada, TX 75173. This budget will raise more revenue from property taxes than last year's budget by an amount of \$251,141.00, which is a 64.95 percent increase from last year's budget. The property tax revenue to be raised from new property added to the tax roll this year is \$41,560. The total property taxes are to be \$637,802.00.

9. Discuss and Consider action on Ordinance Number O082223, an ordinance of the City of Nevada, Collin County, Texas approving and adopting a budget for the fiscal year beginning October 1, 2023, and ending September 30, 2024; providing that expenditures for said fiscal year shall be made in accordance with said budget; appropriating and setting aside the necessary funds out of the general and other revenues for said fiscal year for the maintenance and operation of the various departments and for various activities and improvements of the city; providing a repealing clause; providing a severability clause; and providing an effective date.

10. Public Hearing- A PUBLIC HEARING ON THE PROPOSED TAX RATE WILL BE HELD ON August 22, 2023, AT 7:00PM AT City of Nevada City Hall, 424 E. FM 6 Nevada, TX 75173. The proposed tax rate is greater than the voter-approval tax rate but not greater than the de minimis rate. However, the proposed tax rate exceeds the rate that allows voters to petition for an election under Section 26.075, Tax Code. If the City of Nevada adopts the proposed tax rate, the qualified voters of the City of Nevada may petition the City of Nevada to require an election to be held to determine whether to reduce the proposed tax rate. If a majority of the voters reject the proposed tax rate, the tax rate of the City of Nevada will be the voter-approval tax rate of the City of Nevada.

A tax rate of \$0.320000 per \$100 valuation has been proposed by the governing body of the City of Nevada.
